Visit with Gert even briefly and you're taken by how lovely, endearing and approachable she is and her quick sense of humor. It's interesting to know that her mother, Persana Deimling, was one of the exceptionally intelligent children followed by Stanford University's Dr. Lewis Terman, the father of education of the gifted. Gert grew up in Calistoga and graduated, as her mom and dad did, from Stanford University. Later Gert was a teacher, volunteered as a 4H Horsemanship Leader and with North Bay Regional Center advocating for people with disabilities.

GIVEN NAME: LEON

It was at Stanford that Gert met her future husband, Leon Reynaud Jr., who grew up in Santa Rosa. As his ancestors were French, they referred to him as "Mon petit coco" a term of endearment. He preferred the shorter version of Coke.

Coke, you may know, was an original member, along with his horse, Pepe, of the Sonoma County Trail Blazers, and then of our Wild Oak Saddle Club. Many years ago, Coke shared his love of horses with Gert and their children.

A LONG TIME ALOFT

Gert can't help but laugh to recall when she and good friend Gail Wood waited for a mare to foal. The two of them decided to stay with and watch over the expectant horse. WOSC Financial Report

The Club's CPA who oversees our accounting, Kathie Leader, was previously Director of Finance for Luther Burbank Center for the Arts. She has worked for WOSC for nearly a decade.

Hello, my name is Kathie Leader, and I am the accountant who oversees your club accounting (which is performed by three of us in the office) and prepares your financial statements.

Wild Oak Saddle Club holds an IRS exempt status as a 501(c)(7) Social club. This status requires that we uphold certain requirements to maintain our tax exempt status. One of those requirements is that the club must be primarily supported by membership fees, dues and assessments, however the club may supplement its income from non-membership sources. In order to meet the high costs of maintaining our aging facility, our club supplements its income with a limited number of non-member events. The IRS code allows us to earn no more than 15% of our revenues from non-member use of the facility. We monitor this requirement very closely and report our current percent of use to the board and the membership in our monthly financials.

At the last board meeting, I provided an analysis to clarify the accounting for your facility improvement and maintenance expenditures along with how your annual assessment, member and other events, and Derby Day revenues support these expenditures as follows:

The club expends an average of \$210,000 in facility maintenance and upgrades each year (averaged over the last 8 years). This expense is supported by revenues also averaged over the last 8 years of (1) \$67,300 in annual assessments, (2) \$83,400 in Derby Day contributions and (3) \$60,400 in member and other event revenue (tracked very closely to ensure we are within IRS requirements). Without these revenue sources, the club would have to significantly raise membership dues and assessments.

The board has strived to maintain at least \$375,000 in cash reserves to allow for payment of future facility expenditures. At the beginning of 2022 we had a cash balance of \$507,975 of which we spent \$378,567 on capitalized facility costs (any costs under \$2,500 are expensed on our P&L - the total facility costs as of September 30, 2022 are \$437,846). As you know, we replaced the deck this year - accounting for a significant amount of this year's expenditures. The cash balance as of September 30, 2022 of \$374,446 is slightly below our board designated reserve.

Lori has copies of this analysis if you would like to see it.

Also, there will be another report provided for the club's Annual Meeting in January.
